Cancelled Election

As for the write-in deadline (March 3, 2025) for May 6, 2025, special district election, the number of candidates that filed for trustee is equal to or less than the number of positions to be filled at the election. Therefore, the election administrator is notifying the governing body of the district that the election has been cancelled. The beginning of this term of office shall start after Election Day-May 6, 2025. An oath of office shall be completed at that time in order to swear in the trustee for the new term.

Purchase of Hospital Beds

We can order all 5 now to lock in the price and will pay for 3 before the end of June for \$37,202, and 2 before the end of 2025 for \$24, 804, for a total of \$62,010.00.
